Entrance to TMS will open at 7:00 a.m. on Saturday and Sunday with entrant check-in and tech beginning shortly thereafter. If you prefer to walk the course, it should be done prior to the drivers' meeting. A parade lap will be provided immediately following the drivers' meeting. The TMS concessions will be open for the food the beverage needs of our participants and guests. *TMS Victory Circle* will be open for pictures, so bring your camera.

There will be a Saturday evening dinner catered by Vance Goodbye's at 6:30 p.m. at the Hampton Inn and Suites. Dinner will consist of BBQ Brisket, Chicken, and Sausage with Pinto Beans, Potato Salad, Coleslaw, Rolls and Butter along with a variety of drink options. Desert will be Peach Cobbler.
